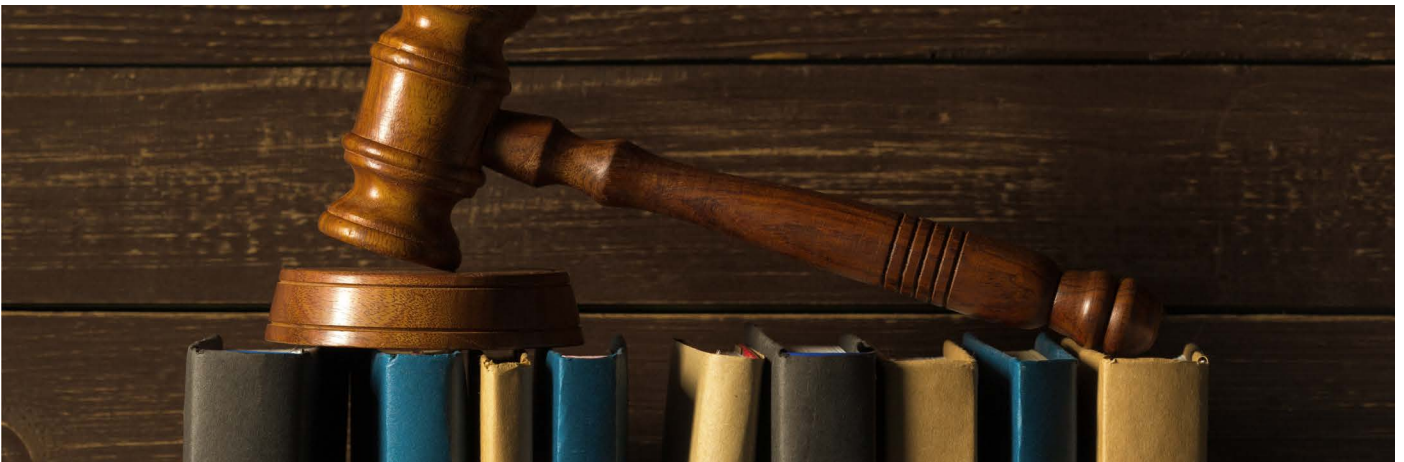
## DEBT COLLECTION

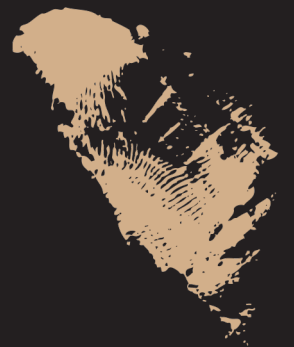
# CRIMINAL LAW

Additionally, our lawyers appear before the Federal Supreme Court in Abu Dhabi and federal courts in other Emirates. Furthermore, they can apply for temporary release on bail, whether financial or personal and file civil claims before criminal courts to seek compensation for the client/victim's damages due to the crime, ensuring appropriate civil compensation is obtained and executed.

We provide legal advice and guidance on personal and family matters, applying Islamic Sharia and various relevant laws concerning other religions. Our expertise covers the following cases:

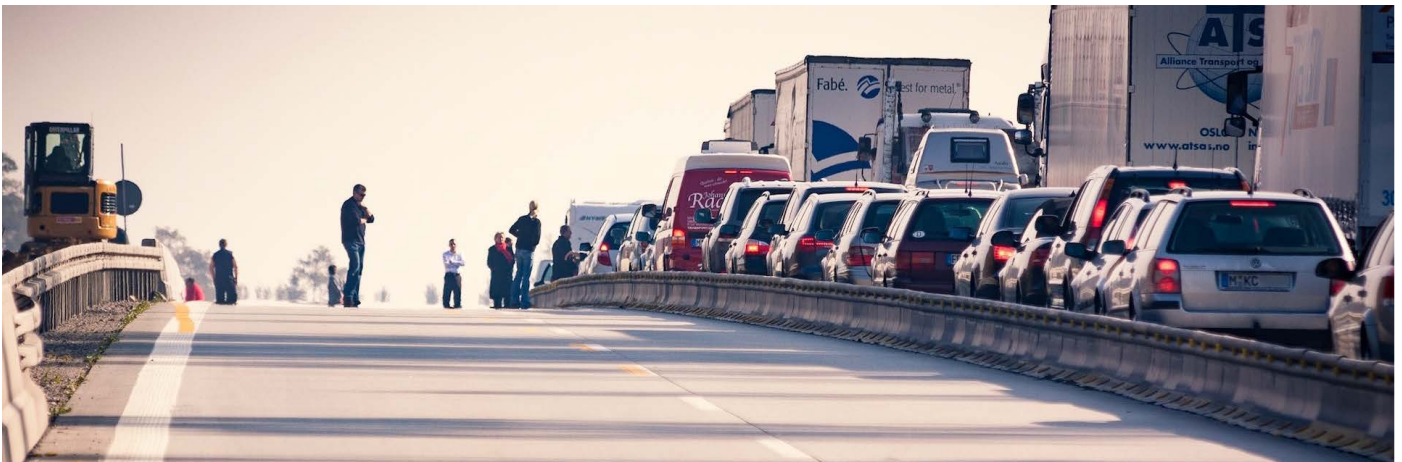
- Disputes and lawsuits related to divorce/separation.

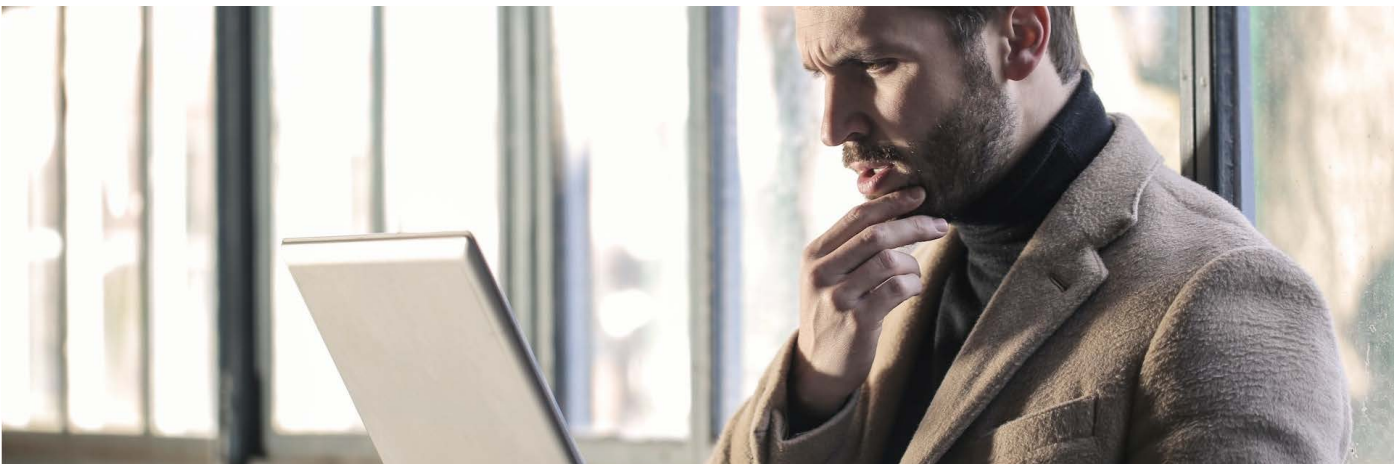
